2019 “TRACTOR HOURS” AUCTION - BUYER’S CONTRACT - DETAILS

SUBJECT: 25 to 150 “Tractor Hours” for use of certain John Deere tractor equipment.

TERMS: Tractor equipment must be used between April 1st and October 31st, of 2019.

A BUYER that does not use the equipment and purchased hours within the above specified time period will forfeit their right to use the equipment and hours purchased. No refunds will be given. If inclement weather impacts time and conditions to use the hours purchased, stipulations may be made at the discretion of CYFEA and 4RIVERS EQUIPMENT.

BUYER must provide the CYFEA and 4RIVERS EQUIPMENT the following information prior to any equipment use:

- A current General Liability Insurance Binder, acceptable by 4RIVERS EQUIPMENT;
- Intended equipment transportation information, both to and from the nearest available 4RIVERS EQUIPMENT dealership; and
- Payment in full to the CYFEA, by check or credit card, at the time of sale.

ADDITIONAL CONDITIONS:

BUYER is responsible for all equipment transportation costs to and from the 4RIVERS EQUIPMENT dealership location of their choice. This transportation must be arranged and paid for prior to the tractor equipment ever leaving the 4RIVERS EQUIPMENT dealership location. Tractors may be hauled by the BUYER or by someone other than 4RIVERS EQUIPMENT with approval from 4RIVERS EQUIPMENT.

BUYER agrees to provide 4RIVERS EQUIPMENT with a physical address of where the tractor will be transported to, kept, and used during the allotted purchased time period, prior to said tractor(s) leaving the 4RIVERS EQUIPMENT dealership.

Each block of hours (25 hours per block) that will require multiple or different tractors, will address one individual piece of equipment each, with regard to all insurance requirements and transportation needs. If a BUYER purchases all or part of the 150 total hours available and needs two different tractors, there will be one contract--unless the BUYER needs a different tractor at different time periods. In this event, there will be two contracts, and each contract will require the same complete documentation.

BUYER is responsible for all fuel and DEF used necessary to run and maintain the tractor while in use, and the tractor is to be returned filled with fuel and DEF.

BUYER is responsible for any and all routine maintenance of the tractor(s) while in use. An Operator’s Manual, specific to the tractor being used, as well as any necessary and helpful instructions, will be provided by 4RIVERS EQUIPMENT, at the time of engagement. Said Operator’s Manual will remain with the tractor(s) at all times, including when it returns to the dealership of origin. In the event that the Operator’s Manual is lost or damaged, the BUYER agrees to pay for a replacement copy, specific to the tractor(s) being used.

Any and all damage to the tractor(s) used by the BUYER will be repaired at the expense of BUYER by 4RIVERS EQUIPMENT. It is the responsibility of the BUYER to identify any and all damage to 4RIVERS EQUIPMENT at time of equipment initial pick-up.

By signing below, BUYER agrees to all of the above written Terms and Conditions and recognizes that this is a legally binding contract. Furthermore, BUYER agrees to any and all announcements made at the time of CYFEA “Tractor Hours” Live Auction event on January 31, 2019 at the CO Farm Show in Greeley, Colorado which takes precedence over any printed promotional material.
